Conditions for participation:

There are no special entry requirements, however, because of the content of the presentations, the congress is recommended only for permanent makeup artists. Companions may not attend the congress; a companion package may be purchased for the Awards Ceremony on April 17 and for the subsequent Gala Dinner.

The conference is preceded by the 5th Hungarian WULOP international permanent makeup competition preliminaries and the PMU Diamond competition. Thus the event is simultaneously a competition and an international PMU conference featuring successful professionals, many techniques, and opportunities for development. The WULOP congress and competition will be held in Budapest and, in the case of foreign speakers, interpreters will be used. Participation in the conference is not a prerequisite for entering the competition.

Dress code:

During the conference: Business Casual (comfortable business attire).

Gala Dinner: Black & White or Silver & Gold – ladies should wear black-and-white or silver/gold dresses; gentlemen should wear a dark suit. The organisers reserve the right to refuse entry for clothing that significantly diverges from the dress code.

Punctuality:

The organisers strive for punctual event management; the maximum permitted lateness is 5 minutes. Please show respect for the speakers by being punctual during the event.

Available fee packages**Bronze package:**

Admission to the conference and accompanying events for the entire duration (April 17-18, 2026), PMU gifts, raffle with valuable prizes.

Fee: HUF 99,000 + VAT ≈ 270 Euro + VAT

Silver package:

Admission to the conference and accompanying events for the entire duration (April 17-18, 2026), entry to the Awards Ceremony and the subsequent Gala Dinner and After-Party, PMU gifts, raffle with valuable prizes.

Fee: HUF 139,000 + VAT ≈ 370 Euro + VAT

VIP package:

WULOP competitor discount:

Family members and companions may attend the awards ceremony and Gala Dinner; the fee is HUF 40,000 + VAT. ≈ 110 Euro + VAT

Cancellation policy

After registration, cancellation is possible with a 10% administration fee, which will be deducted from the paid amount. After the registration deadline (March 31, 2026) cancellation is not possible and fees will not be refunded.

Data processing
